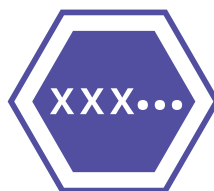

Database Security: Detect, alert and prevents intrusion risks in real-time.

Dynamic Data Masking (DDM): Conceal sensitive data and mask in real-time.

- Column Level Masking (Including via Stored Procedures or Views)
- Conditional/Row Level Masking (Including via Stored Procedures)
- Multiple Masking Functions
- Database and Application Layer Remain Unchanged
- Data at Rest Remains Unchanged



Database Activity Monitoring (DAM): Monitor database activity up to the column level.

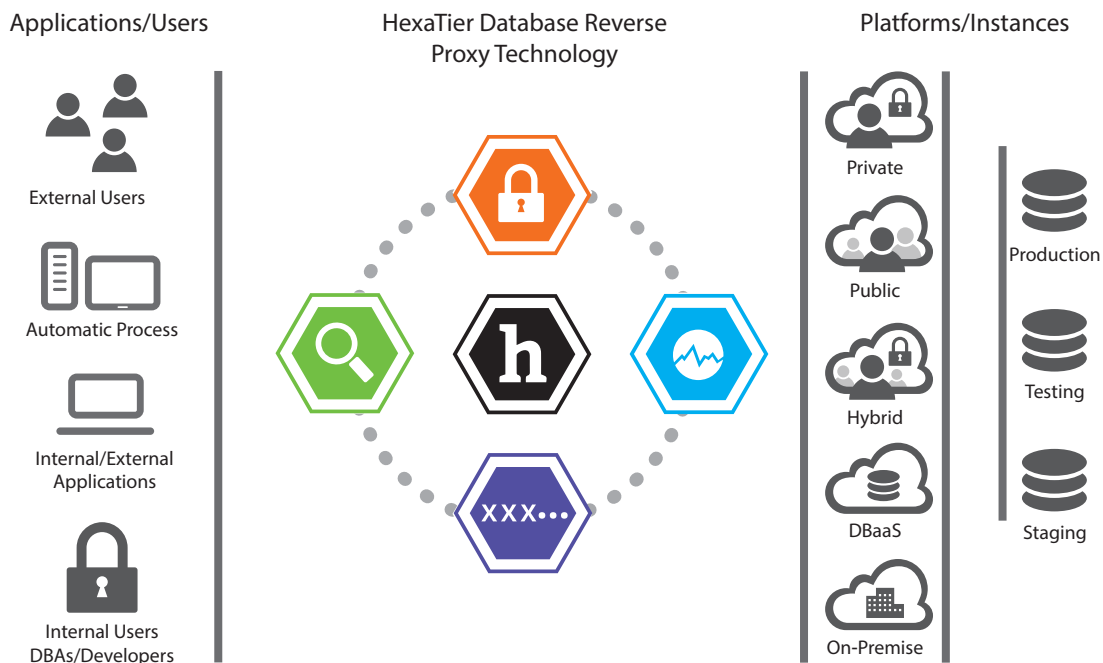
- Audit of Logins, Admin Commands, Access, Queries, Stored Procedures
